

1st mission, 15th -18th January 2018

- Assessment Report MS experts analysed all relevant documents and legislation related to cooperation of the Government and civil society through the Council in order to provide a complete overview of the situation that would enable implementation of subsequent activities.
- MS experts held several meetings with relevant institutions and other stakeholders in the BC as well as meetings with representatives of the Delegation of the EU and CFCD as regards the technical and operative issues of the project implementation and the follow up of the 1st mission, with discussion of the mission plan for the rest of the project implementation.
- □ A meeting with the Ambassador of the Republic of Croatia to the BC.
- revision of the Decision for establishment of the Council for cooperation between the Government and civil society prepared and discussed with BC partners.
- Written comments on the Form for giving support for a candidate for a member of the Council for Cooperation with and development of the civil society from association and foundations was The MS experts provided the BC with the knowhow and presented Croatian good practice experience regarding the selection process for the representatives of the CSOs in the Council.













2nd mission, 12th -16th February 2018

- As a follow up of Activity 1.1, the MS experts developed and prepared operational methodology for the Council by preparing a document with comments on Draft Rules of Procedures of the Council for cooperation between the Government and civil society and they drafted Rules that include comments from STEs.
- The MS experts analysed and revised the Strategy for cooperation of the Government with civil society (2012 2017).
- □ Following the analysis, **revision of the Strategy with recommendations** for the priorities of the Draft-Action plan for the period 2018-2020 was prepared.
- Numerous meetings of STEs with the relevant state bodies: Ministry of Finance, Ministry of Labour and Social Policy, Ministry of Information Society and Administration and Central Registration, as well as with representatives of the network of civil servants for cooperation with civil society organizations.
- A workshop with relevant stakeholders using a world café method with the aim to make a revision of the Strategy for cooperation of the Government with civil society 2012-2017.













3rd mission, 12th-16th March 2018

- The Kick-off event on 13th March 2018 in EU Info Centre Skopje in order to present the Project to more than 50 attendees. In order to ensure good visibility of the Project, leaflets and other promotional materials were prepared and disseminated, presenting all relevant information about the Project. Moreover, media representatives were invited and a press release was issued.
- A series of consultative meetings both with representatives of administrative bodies and with representatives of CSOs. Along with Croatian STEs from the Office for Cooperation with NGOs, one STE from the Croatian Ministry of Finance also participated in this mission (Ms Filipčić), and thematic meetings with colleagues from the BC Ministry of Finance were organized.
- MS experts analysed all relevant existing documents and draft documents related to priority measures from the Strategy for cooperation of the Government with civil society. The analysis aimed at providing a complete overview of the proposed solutions and elaboration of recommendations regarding each specific document.
- STEs prepared first draft of the Action Plan that includes activities, a timetable for their implementation and indicators for subsequent monitoring of implementation, and it was submitted to the Unit at the beginning of April 2018.

- Second session of the Council for cooperation with and development of the civil sector the premises of the Government in Skopje on 14th of May. Project team members presented recommendations/amendments for improvements of the Decision for establishment of the Council for cooperation between the Government and civil society.
- Additional consultations with key state administration bodies including Council for cooperation with and development of the civil sector regarding the draft Action plan for implementation of the Government Strategy for cooperation with and development of civil society 2018 – 2020.
- Two days Workshop for capacity building of the members of the Network of civil servants for cooperation with civil society on theoretical and practical models of monitoring the implementation of the Government Strategy for cooperation with and development of civil society 2018 2020 and the Action plan Skopje, May 16th and 17th 2018 at the Club of the state administration bodies.
- On-the-job training of the staff of the Unit for cooperation with NGOs of the General Secretariat for coordination and monitoring of the implementation of the new Action plan 2018 2020 aimed to improve the knowledge and skills of the staff of the Unit necessary for the efficient coordination and monitoring of the implementation of an operational document. Additionally, in cooperation with colleagues from the Unit, examples of specific forms for monitoring the Strategy were developed which will could be used after the implementation of the project in their daily work related to the coordination and monitoring of the implementation of the implementation of the Strategy.

PROJECT OUTPUTS AND OUTCOMES 6th mission, 4th - 8th June 2018

- Workshop for members of Council for cooperation with and development of the civil sector June 6th - operational planning of the Council's work and connecting of the members of the Council.
- Workshop for the members of the Council for cooperation with and development of the civil sector, representatives of civil sector, June 7th strengthening the capacity of members of the Council for communication with civil society organizations from the sectors they represent and communication between the members of the Council and development of a communication plan.
- Both workshops demonstrated the need and importance of discussing topics related to the communication methods of civil sector representatives with the subsectors who chose them as members of the Council.
- STE analysed relevant documents and draft documents related to priority measures from the Strategy aimed at providing a complete overview of the proposed solutions and elaboration of recommendations regarding each specific document, according internationally recognized best practices in specific areas while taking into account local circumstances, all of the previous outputs in the Project and information gained through meetings held through project implementation, in order to adjust recommendations to specific local needs. The result were also several additional outputs, namely a Handbook with examples of tender documentation regarding the output related to written comments on legally binding document for standardisation of the state funding for CSOs.
 MS Project leader participated in the "Open Days for Initiatives of Civil Society Organizations: "Practice Cooperation between Government and Civil Society Organizations How to Improve Cooperation?" organized by the Government.

PROJECT OUTPUTS AND OUTCOMES 7th mission, 2th - 6th July 2018

- On 5th July 2018, Round table 'Further institutionalisation of structured mechanism/s for cooperation between the government and civil society' Club of the state administration bodies an awareness raising event discussing potential challenges in the future implementation of the Strategy and Action plan with representatives of the Council and competent state administrative bodies.
- In order to ensure good visibility of the project and its results, leaflets about the new Council and the role of the Unit for cooperation with NGOs in coordination of monitoring the new Action plan were prepared and disseminated.
- Concerning the adoption of the Strategy, STEs produced an expert opinion on the comments of the Council members regarding the Draft Strategy and the Action Plan. The aforesaid opinion was translated into Macedonian and is to be part of the accompanying materials in addition to the text of the draft Strategy and the Action Plan when it comes to the adoption of the Government.
- Project team organized several follow up meetings with representatives of CSOs in the Council, regading the development of the communication plan (follow up to training conducted in the 6th mission) meeting with members of Blueprint group in the area of economy and finance, meeting with members of Association Resource center of parents of children with special needs and meeting with members of anticorruption network.
- MS Project team participated in the second event organized by the Government "Open Days for Initiatives of Civil Society Organizations: "Practice Cooperation between Government and Civil Society Organizations - How to Improve Co-operation?".

8th mission, 3th - 7th September 2018

- In order to present new Action plan for the period 2018 2020 for implementation of the Strategy, share mutual experience in cooperation with civil society, and strengthen cooperation between local self-government units and CSOs, **3 meetings was/will be organized** in Tetovo (4th September), Skopje (5th September) and Bitola (7th September).
- On September 5th 2018, **Project Steering Committee meeting** with the aim to provide quality supervision of the implementation of this Twinning light project.
- The Final event 6th September 2018, in order to present the project results (including also a review of lessons learned and key recommendations of the project) to the stakeholders, the media and other relevant participants. In order to ensure good visibility of the project results
- Leaflets printed and disseminated presenting all relevant information about the project, Council and Unit for cooperation with CSOs.
- Media representatives invited and a press release issued with purpose to consolidate and disseminate the results and impacts of the project to all stakeholders, as well as to formulate conclusions on the activities to be followed in order to further develop the stimulating environment for civil society development.
